(ii) Valid Permanent Registration Certificate from Pakistan Engineering Council (PEC) issued on or before the closing date for submission of applications is required.

Terms & Conditions:

- 1) Both Male/Female candidates having domicile of Province of Punjab can apply.
- 2) Appointments shall be made strictly on contract basis, under "The Contract Appointment Policy, 2002" initially for a period of 01 year (non-transferrable), extendable subject to good performance.
- 3) Complete application alongwith attested copies of all educational certificates (i.e Matric, F.Sc etc) / degrees / diplomas, copy of domicile, valid CNIC, working experience certificates (if any) and 02 latest passport size photographs must be submitted in the office of Vice Chancellor, Faisalabad Medical University, Faisalabad.
- 4) Name of the post, applied for, should be clearly mentioned.
- 5) In case of 'O' Level & 'A' Level, equivalence certificate must also be submitted.
- 6) Candidates are required to bring original documents/ certificates at the time of interview.
- 7) Age relaxation in upper age limit as per Govt. of the Punjab, S&GAD Notification & recruitment policy 2002.
- 8) Recruitment shall be made strictly on merit in accordance with contract/recruitment policies and instructions issued from time to time by Govt. of the Punjab.
- 9) Candidates who are government servants/working in autonomous bodies should apply through proper channel.
- 10) Incomplete applications as well as the applications received after the closing date shall not be entertained in any case.
- 11) Authority reserves the right to cancel, increase or decrease the number of posts at any level without assigning any reason.
- 12) No TA/Dh will be provided in any test or interview.
- 13) Candidates are advised in their own interest to make sure before applying that they fulfil all the requirements of the rules relating to the post as mentioned above.
