Terms & Conditions:

- Both Male/Female candidates having domicile of Province of Punjab can apply.
- Appointments shall be made strictly on contract basis, under "The Contract Appointment Policy, 2022" initially for a period of 01 year (non-transferable), extendable subject to good performance.
- Complete application alongwith attested copies of all educational certificates (i.e. Matric, F.Sc. etc.) / degrees / diplomas, copy of domicile, valid CNIC, working experience certificates (if any) and 02 latest passport size photographs must be submitted in the office of Vice Chancellor, Faisalabad Medical University, Faisalabad.
- Name of the post, applied for, should be clearly mentioned.
- In case of 'O' Level & 'A' Level, equivalence certificate must also be submitted.
- Candidates are required to bring original documents/ certificates at the time of interview.
- Age relaxation in upper age limit as per Govt. of the Punjab, S&GAD Notification & recruitment policy 2022.
- Recruitment shall be made strictly on merit in accordance with contract/ recruitment policies and instructions issued from time to time by Govt. of the Punjab.
- Candidates who are government servant/working in autonomous bodies should apply through proper channel.
