INSTRUCTIONS FOR POSTS AT SERIAL NO. 1 TO 08:

- From Serial No. 01 to 08, male and female candidates are required to submit their applications, along with attested copies of CNIC, Domicile, PRC, two passport-size photographs, and educational documents, either by post or by hand. The application should be addressed to District & Sessions Judge, Karachi East, M.A. Jinnah Road, Karachi.
- A separate application form must be filled and submitted for each post (if applying for more than one position).
- Incomplete applications and documents shall not be entertained or processed after the closing date.

GENERAL INSTRUCTIONS FOR ALL POSTS:

- List of eligible and ineligible candidates for all the posts shall be affixed on the Notice Board of District & Sessions Court, Karachi East as well as upload to the website of this Judicial District East i.e. <https://districtcourteast.gos.pk/> for inviting objections, if any.
- Female candidates should also be provided equal opportunity to participate.
- 5% quota reserved for candidate with disability. They are required to submit CNIC having wheel chair logo issued by NADRA and valid Disability Certificate, issued by the concerned Government Hospital.
- In case of a Government Servant, who has served in connection with affairs of Federation/Province for a period of not less than three (3) years, the upper age limit shall be thirty (30) years as per rules.
- Over-age candidates having upper age limit up to 5 years (if qualified in test/interview) may get relaxation upon approval by the Honorable Chief Justice, High Court of Sindh, Karachi.
- The offer of appointment shall only be issued to those successful candidates who are found eligible in all aspects and their documents including educational documents, PRC, domicile and other certificates will be verified from the concerned issuing authorities.
- Any External Influence for Selection Will Lead to Disqualification for the Post Applied for the Decision of the Departmental Selection and Promotion Committee (DSC) Of this Court shall be final.
- Number of posts may increase or decrease at any stage.
- Candidates must bring their original documents at the time of interview.
- No TA/DA will be provided for test/interview.
- Last date of submission of application is 07.12.2025
